Land 130M NE Of 60 Newton Park Kirkhill

#### Erect 94 Houses and Flats with associated roads and services

Lindsey Stout brought up the effect on the residents of Newton Park, currently no through road, of this application, which would make Newton Park a loop road with two entrances/exits for the whole estate, old and new build and increase traffic.

This planning application had not been discussed by the Community Council because the Community Council was not in session at this time and so no one on the Community Council had been informed. The effect on the existing settlement will be significant. Cameron Kemp will draft a reply and circulate it and see if the Council will accept a late comment.

## 7. Merger of K.B.C.T. and K.C.C.

Erik Lundberg from Kirkhill Community Centre and Mary Andrews from Kirkhill and Bunchrew Community Trust visited to discuss the proposed merger.

The proposal at this stage is to rationalise the efforts of the volunteers in both organisations and to better engage with the community. Both bodies are fully supportive of the merger. The proposal has gone to OSCAR and is in the consultation phase. All the email responses so far have been positive. There will be a stand at the Craft Fair to publicise the merger.

To merge, both bodies will require to hold an Extraordinary General Meeting and to send their paperwork to OSCAR by May or June 2020. The K.B.C.T. will dissolve and transfer its assets to the K.C.C. The K.C.C. will undergo a name change to Aird Community Trust (ACT). An expanded board would run the new organisation, with working groups covering the work of the current groups.

The Community Councillors were in full support of the proposal. Cameron Kemp will draft a letter from the Community Council to support the proposal to OSCAR.

Erik Lundberg discussed the revamping of the current Kirkhill and Bunchrew website, with an opportunity for Kirkhill and Bunchrew Community Council to have a page to put up the minutes. The current link on the website to our Facebook page is not accessible to everybody.

Mary Andrews suggested that the list of the current community councillors should be put up on the website.
