#### 5. Planning Issues

### Springfield Properties plc

## 19/00409/PAN and associated reference 19/01603/PAN

The proposed development to the west of Mansfield Park was discussed and the following points were made:

- Meeting organised by residents on 9/5/19 and noted that there was unanimous objection from those present;
- There are several development sites already available in the village so no need for this
  one;
- This site is not in the local plan;
- Community facilities must be provided for any new development;
- The School is at the limit of its capacity;
- An upgrade of the B9164 would be required if there was to be an access from this proposed development;
- This is a high density development designed to maximise profit for the developer not in keeping with the rest of the village;
- Mr Wilson has written to Springfield objecting to access being taken through Mansfield
   Park and expressing concerns about the existing drainage arrangements.
- The Community Council will keep a look out for an application being submitted for this development.
